- Will there be an additional rack for storage closet near nurse station?
 This location was an example and per the RFP this location is not specifically scheduled to get a CCTV system. Adequate rack space will be provided by RISD at any location a system will be installed.

Cameras **may** be placed in Multipurpose rooms such as cafeteria, gymnasium or common areas.


